### Memorandum of Understanding

Dr. M Arockiasamy Xavier, SJ**, hereinafter referred to as "SJC" which expression shall unless repugnant to the subject or context thereof in this Agreement shall include its executors, successors and permitted assigns of the FIRST PART.

And

**Nallas Software Solutions Pvt Ltd**, a company having its Registered Office at **India Land Kgisl Tech Park, Block A, SEZ - Keeranatham Rd, Saravanampatti, Coimbatore, Tamil Nadu**, represented herein by its authorised signatory, **Senthil Paramasivam**, hereinafter referred to as "NALLAS", which expression shall unless repugnant to the subject or context thereof in this Agreement shall include its executors, successors and permitted assigns of the SECOND PART.

WHEREAS, SJC is in the field of imparting Education to Students, AND WHEREAS NALLAS is a Software Services Company situated at Coimbatore.

Both Nallas Software Solutions Pvt Ltd and SJC have been referred individually as Party and jointly as Parties.

AND WHEREAS SJC proposes to enter into this MoU with Nallas Software Solutions Pvt Ltd for the purpose of developing a platform for interaction in the area of curriculum design, training and placement, psychological well-being of students and employees and other areas.

AND WHEREAS the parties to this MoU agree that this MoU shall be valid for a period of three (3) years from the date of signing of this MoU (hereinafter referred to as the Period)

**NOW THEREFORE THE PARTIES HERETO AGREE AS FOLLOWS:**

This is an independent non-exclusive, non-transferable agreement between the parties and the parties hereunder are free to take the services of any other third party in relation to the purpose mentioned hereinabove.

This MOU formalizes a relationship between SJC and Nallas. The intent of the Parties is to develop a long-term mutually beneficial relationship whereby NALLAS will share its domain expertise with SJC in the field of Software Development, students training and recruitment and SJC will share from the college, its services of faculty in the field of counselling and psychology, professional communication, and any other data and information of common interest with NALLAS SOFTWARE SOLUTIONS Pvt Ltd.

Set forth below is the understanding between SJC and NALLAS Software Solutions Pvt Ltd. in support of the programmes offered by SJC:

1. SJC will have the active assistance of NALLAS in envisioning, designing, developing and modifying its curriculum.


2. SJC faculties will be trained in the recent developments in the IT arena, from time to time, depending upon the requirements of the SJC and at the convenience of the faculty of NALLAS Software Solutions Pvt Ltd.
3. NALLAS Software Solutions Pvt Ltd. would make available internship and placement opportunities to the students of SJC on a need basis.

8. Periodicity: This MOU is valid for a period of three (3) years from the date of signing by both the Parties and may be reviewed and renewed on mutual consent of both Parties thereafter.
9. Termination: Either of the parties may terminate the Contract voluntarily if it so wishes or if it defaults or breaches any of the terms and conditions of this MoU, by giving minimum of sixty (60) days' notice to the defaulting party.

Entire agreement: 20Cube Logistics Pvt Ltd and the SJC acknowledge that they have read this agreement, understood it and agree to be bound by its terms and further agree that it is the complete and exclusive statement of the agreement between the parties, which supersedes all proposals oral or written, and all other communications between the parties relating to the subject matter of this agreement.



**MEMORANDUM OF UNDERSTANDING**

This **MEMORANDUM OF UNDERSTANDING** is made and entered on this **26th March 2022**, by and between **Athena Technology Solutions Pvt. Ltd., Chennai**, (hereinafter referred to as the "**ATHENATEC**"), a Corporate company registered under the Companies Act 2013, under the Ministry of Corporate Affairs, Government of India and having its registered office at **No. 186, SR Towers, 2<sup>nd</sup> Cross Street, Shanthi Nagar, Chromepet, Chennai – 600044**, (which expression shall, unless inconsistent with the context or meaning thereof, be deemed to include its subsidiaries, nominees, successors and permitted assigns) represented by **Senthil Ranganathan** the CEO of Software Company and the authorized signatory of the FIRST PARTY

AND

**St. Joseph's College (Autonomous), Tiruchirappalli**, an educational institute having its registered office at **Tiruchirappalli, Tamil Nadu 620002** (hereinafter referred to as the "**INSTITUTION**"), which expression shall, unless inconsistent with the context or meaning thereof, be deemed to include its subsidiaries, nominees, successors and permitted assigns) represented by **Nominated representative correspondent** of the SECOND PARTY. Further Nominated representative and correspondent nominate **PRINCIPAL or Head of Department or Placement Officer** as a Single Point of Contact (SPOC) and other operational procedures.

**Now it is duly communicated and hereby agreed by and between the parties as follows:**

**1. SCOPE OF THE AGREEMENT:**

This agreement sets forth the ground for association between ATHENATEC and the INSTITUTION on the following aspects.



## 2.OBJECTIVES:

1. To conduct campus hiring for the selected final year Postgraduates / Alumni graduates passed in last 2 years in the premises of the INSTITUTION (on-site/ virtual).
2. Conduct Interview Process for the best Candidates in the following Course/Discipline.
  - M.Sc/B.Sc (Computer Science/IT/Mathematics/Data Science)
  - MCA/BCA
  - Other Equivalent Master's / Bachelor's degree candidates with Computer Science and Information Technology (IT) related only will be considered
3. Based on the requirement, to select minimum of 5 to maximum of 10 Candidates and hire them as **Graduate Trainees** who will undergo intensive software development training, specific MES domain training, product training and soft skills.
4. After successful completion of the training program, candidates need to pass the training completion test, post this they will be absorbed as permanent employees of ATHENATEC.
5. On successful completion of the Training & Test (which is considered as a probationary employment with ATHENATEC), Graduate Trainees will be hired as **Software Engineer** under the Graduate Program of ATHENATEC.
6. This is an initiative to provide opportunities, establish and develop tier-2 / tier-3 cities
7. Provide expertise in the design of the curriculum for the programmes conducted by the Institution
8. Provide Internship / Project opportunities for the final year students

## 2. PROJECTS:

MES (Manufacturing Execution System) domain & product-based projects which involves Requirement gathering, Development, QA activities & Implementation, catering to various US based and non-US based clients.

## 3. GRADUATE PROGRAM:

The Graduate Program conducted by ATHENATEC is considered as a **Probationary Employment**, on successful completion of which the trainees will be absorbed as **Full-Time Employees** by ATHENATEC.

- During the training/probationary period the designation of the engineers would be **Software Trainee**.
- During the training/Probationary period the trainees will receive a consolidated pay of **Rs.20,000 per month for Post Graduate(PG) and Rs.15,000 per month for Under Graduate (UG) candidates**.
- The above-mentioned pay for all trainees shall be paid through the Athenatec's official bank partner HDFC by creating an individual account for the trainees and every month, the pay will be dispersed to the trainees.
- Athena, also planning to start the training program to the selected students during the last semester of academic calendar and discussion will be made with the college management to enable the students to attend the trainings and small project assignments.

### 3.1 Commitment from hired Graduate Trainees: -

- Hired Trainees will have to **commit for minimum 3 years period**. During this period, they agree that they will not quit the company for any reasons. They will sign a bonded employment agreement with submission of one of their original certificates (e.g X certificate) in possession of the employer and will be duly returned once the 3 years period reaches its closure.
- They will undergo .NET and other skill set training in our Chennai or Bangalore branches / through online.
- Should be open to work on any of our locations i.e., Chennai or Bangalore or Trichy locations.

### 3.2 MES Intensive Training Program: -

- Initially, they will be on-boarded as Software Trainees in Athena Bangalore branch or Chennai branch or online for 3 to 6 months to complete their training program in .NET + SQL and other technical topics (*Duration will be around 1-2 months*). Followed by Training Assessments & Tests. Trainees will have to successfully pass it with 80%.
- Once they clear .Net training, Trainees will undergo MES Intensive Training Program which will vary from 3 months to 6 months and sometimes it may extend beyond six months as part of the On-the-job training. During this period, trainees will devote their time and focus on completing the training successfully and pass the assessments. This Training will be happening in either Chennai or Bangalore branches only (not online). Followed by Mini Projects, Development of modules, functions and creating scenarios, QA and project documentations etc. MES Training Completion involves evaluation by the Project Leads and Assessment Test. Trainees will have to successfully pass it with 85%.
- Trainees will have to relocate to the location as required.
- Once Training is completed, management will decide on the trainees who will be allocated to Bangalore, Chennai and Trichy.

### 3.3 Career Growth:

Athena as always focuses on the career path of its employees, in empowering providing adequate opportunities for learning, exposure to various client projects, providing additional training if required and also has an open culture to share the ideas and discuss

- **Stage 1: Trainees with Phase 1 -> .NET & SQL Training. Phase 2 -> MES Training**
- **Stage 2: Software Trainees -> Software Developers / Test engineers**
- **Stage 3: Module Lead -> Team Leaders in Development / Testing (QA)**
- **Stage 4: Technical Leader / Business System Analysts / Domain Specialists**

Note: Above is an illustrated Growth time frame range from 0 to 6 years (may vary as per individual's capacity)

### 3.4 Financial Offer package: 0 to 3 years progressive forecast

- For PG: 0-12 Months / till successful clearance of .NET Training & domain specific trainings: **Initial Offer package ->3.00 LPA (25K per month for PG freshers inclusive of PF benefits)**
- For UG: 0-6 Months (Probation Period) – **Initial Offer package -> 1.80 LPA (15k per month)**. After successful clearance of .NET Training & domain specific trainings, completion of probation period CTC will be revised to **2.4 LPA (20k per month inclusive of PF benefits)** based on the performance and review.
- End of 1 year: Based on Performance **annual package ranges from 3 LPA to 4 LPA**
- End of 2 years: Eligible to get **upto50% increment** based on performance ratings.
- End of 3 years: Eligible to get **upto50% increment** based on performance ratings.

Note: This is based on the company performance, business growth, market condition and employee's performance

### 3.5 Permanent Employment:

- On successful completion of the training program, trainees will be absorbed as full-time employees of ATHENATEC under the designation **Software Engineer**. Management of Athenatec will review on those who do not clear their training program whether they can be reconsidered or released. Management decision will be final.
- Whether the associates are Trainees or Permanent employees, they have to comply to Athenatec's Policies, compliances and other terms & conditions strictly. Any deviations will lead to disciplinary measures.
- ATHENATEC will provide official laptops to the graduate trainees, and they will have to maintain their laptops professionally. Rough handling and careless handling of Laptops leading to damages to the hardware & software applications will not be tolerated.

### 3.6 Employment Contract:

- Engineers who are selected for **permanent employment will sign an employment contract (Refer 3.1)** whereby they undertake to stay in employment with ATHENATEC for a minimum period of 36 months.
- In case the Trainees or employees before 3 years, for any reason, breaks the contract with ATHENATEC during this period, then he/she shall **forthwith pay a sum of upto 3,00,000 /- (Rupees Three Lakhs only)**, being the indemnification of the cost of training to ATHENATEC.
- Athenatec Management can hold review and decide on certain cases only if the reason behind the employee's resignation is deemed tenable.

### **3.7 Termination:**

ATHENATEC reserves the right to terminate trainees during the training period as well as the full-time employment for any of the below mentioned reasons.

- If the trainee /employee breeches the terms and conditions of the new graduate program.
- If the trainee/employee is unable to follow the pace of the training and has poor learning ability and performance.
- If the trainee/employee breaches trust and shares confidential information with outsiders.

## **4. TERMS & CONDITIONS FOR THE CAMPUS HIRING AGREEMENT:**

### **4.1 Responsibilities of INSTITUTION:**

INSTITUTION agrees to

- Head of the Department / Placement Coordinator / officer should be available to provide support during the campus hiring process.
- Provide logistical and infrastructural support as and when required for presentation, tests and interviews in the premises.
- Need to provide list of candidates including details like academics, certifications & other achievements if any, that enables us to shortlist the candidates.

### **4.2 Responsibilities of ATHENATEC:**

ATHENATEC agrees to

- Provide the following facilities during the graduate program.
  - Virtual Machine Account or Laptop
  - Communication Account
- Update the INSTITUTION about the training progress of the interns with supporting documents like the test results and performance reviews.
- Further, both the PARTs have the right to inspect and examine the premises allotted to the ATHENATEC at any point of time during the incubation period.

#### **4.3 Non- disclosure and Protection:**

The Parties agree that, always during or subsequent to the business relationship, they will keep confidential and not divulge, communicate, cause to be disclosed, publish, disseminate or otherwise make available or use Confidential Information, except for the Party's own use during the Term of this MoU, for the purpose of enabling productive interaction between the Parties. The Parties further agrees not to cause the transmission, removal or transport of tangible embodiments of, or electronic files containing, Confidential Information from the other Party, without prior written approval of the other Party, that owns the Confidential Information.

#### **4.4 Intellectual Property:**

Except for any rights expressly granted to the other Party, each Party shall retain all right, title and interest and proprietary rights in their own intellectual property. Nothing in this Agreement shall be construed to assign or license any right in each Party's intellectual property to the other party, unless expressly granted herein.

#### **4.5 Termination:**

This MOU may be terminated by either of the party by providing 6 months written notice expressing the intention to terminate the agreement. The Termination Notice shall also be valid when issued without assigning any specific reason/s thereof. However, the termination can be initiated only when there is no batch commencement at the centre.

#### **4.6 Amendments:**

Notwithstanding anything contained hereinabove or in the 'SALIENT RULES FORMING PART OF THE CAMPUS HIRING AGREEMENT' annexed thereto INSTITUTION may at any time amend all or any part of the agreement and its annexure and the ATHENATEC shall be bound by the said amendments. The amendments shall be applicable with immediate effect.

The period of Campus hiring engagement can be extended only by the mutual understanding of the ATHENATEC & INSTITUTION at its discretion if a request is made by either of them.

**4.7 Arbitration:**

Any/all disputes between the ATHENATEC&INSTITUTION shall be referred for arbitration to the person so nominated by the Directors of both the Entity under the Indian Arbitration & Conciliation Act whose decision shall be final and binding upon the parties. The place of arbitration shall be Trichy.



A) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

B) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, Placement, Industrial Visit, Expert Lecture.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:

#### **CLAUSE 1**

#### **CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

#### **CLAUSE 2**

#### **SCOPE OF THE MoU**

- 2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the students of MCA programme. This will provide confidence & smooth transition for students work. Also the Second party may register on the AICTE Internship Portal for the benefit of students.
- 2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.3 Placement of trained students: Second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements.
- 2.4 The first party to take up any program mentioned in MoU. If there is any financial consideration, it will be dealt separately.

2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

### CLAUSE 3

### VALIDITY

3.1 This Agreement will be valid for three years from the date of this agreement until it is expressly terminated by either Party on mutually agreed terms.

### CLAUSE 4

### RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.

**M.3.3. PYROFEROUS TECHNOLOGIES and St JOSEPH'S COLLEGE (AUTONOMOUS), TIRUCHIRAPPALLI**, shall share facilities such as computers, sophisticated equipment, instrument etc and library facilities according to rules and regulations of each institution.

**M.3.4** Exchange programme enabling the faculty members of MCA Programme at **St JOSEPH'S COLLEGE (AUTONOMOUS), TIRUCHIRAPPALLI**, to work for short periods in **PYROFEROUS TECHNOLOGIES** and the faculty of **PYROFEROUS TECHNOLOGIES**, to serve as visiting faculty for guidance in the development program of mutual interest and conduct of intensive course.

**M.3.5** Design and Development of curriculum in new areas of Information Technology, particularly with long & short term courses which will benefit the students of MCA.




